APPLICATION FOR DEFERRED OR SUSPENDED SENTENCE

The undersigned, having entered a plea or having been convicted herein, respectfully requests the Court to defer / suspend sentence and place the undersigned under the supervision of <u>COURT SUPERVISION SERVICS</u>, <u>INC. located at 608 West Highpoint Drive</u>, <u>Stillwater</u>, <u>Oklahoma 74075</u>, <u>Telephone Number 405-533-1462</u>.

If the request is granted, the undersigned agrees:

- 1. To refrain from violation of any city, state or federal law and to advise Court Supervision Services, Inc. within twenty-four (24) hours of any police contact or arrest by any Law Enforcement Agency
- 2. Not to use or be in possession of controlled narcotics except as prescribed to me by a physician, nor to visit any places where controlled drugs are unlawfully sold, dispensed or used
- 3. To not use or possess any alcoholic beverage, including beer, nor to visit or frequent places where alcoholic beverages are exclusively sold
- 4. I will submit to any rehabilitative, medical, psychological or substance abuse program as directed by the court and/or my probation officer and I will submit to urine-analysis testing as directed by my supervision agency or officer
- 5. Not to own, purchase, possess, use, sell, or have under my control any deadly weapon, firearm or destructive device. Nor shall I travel in a vehicle in which a deadly weapon, firearm, or destructive device is present. Nor will I be in the company of any person possessing the same
- 6. To report immediately after sentencing to Court Supervision Services, Inc., located at 608 West Highpoint Drive, Stillwater, Oklahoma 74075 and to report as directed thereafter for the term of supervision
- 7. To notify Court Supervision Services, Inc. before any change of address, telephone number, or any change or employment within twenty-four (24) hours.
- 8. To obtain approval in advance of relocating or traveling between states. The Federal Interstate Company (<u>www.interstatecompact.org</u>) prohibits movement between states of ALL Felony Probationers
- 9. To complete all required treatment plans, programs or activities on or before the requirement date set by the Court
- 10. To submit to immediate searches of my person, vehicle, or residence at any time, day or night, without a warrant
- 11. To avoid associating with persons on parole or probation, or persons with criminal records. To also avoid communication with inmates of any penal institution
- 12. To pay all court costs, fines, District Attorney Reimbursement Fees, restitution, and other miscellaneous costs accruing in this case
- 13. To pay a monthly supervision fee of forty dollars (\$ 40.00) to Court Supervision Services, Inc. for the term of the supervised portion of probation.
- 14. To have a copy of this application and to study the same from time to time so that I will be fully informed regarding my obligations under the deferred / suspended sentence.

I specifically understand the consequences for my failure to follow or complete the rules and conditions of probation may include:

- 1. Advancement of deferment, which could result in, a judgement of guilty and being sentenced to a term of imprisonment or fines not exceeding the maximum provided by law
- 2. Revocation of my suspended sentence
- 3. Incarceration within the Department of Corrections, jail time or other sanctions ordered by the court

I hereby waive extradition to the State of Oklahoma from any jurisdiction in or outside of the United States where I may be found. I also agree that I will not contest any effort by any jurisdiction to return me to the State of Oklahoma. I understand that I may be disciplined for violation of any of these rules and that the deferred / suspended sentence may be accelerated / revoked upon motion of the State following hearing and this could result in my incarceration in the Department of Corrections or the Payne County Jail.
